Project SESEI background, Project Partners, Objective and Priority Sectors:

<u>Introduction to Project SESEI</u>: **The SESEI project (**Seconded European Standardization Expert in India) is a project co-funded by five European partners, operating from New Delhi, India, with the objective to increase the visibility of European standardization in India and to promote EU/EFTA-India cooperation on standards and related activities.

<u>Project Partners</u>: The SESEI Project (http://sesei.eu/) is managed by the European Telecommunications Standards Institute (ETSI - http://www.etsi.org/ - EU recognized Standards Organization for Telecommunication sectors) and is further supported by two other EU recognized Standards Organization, namely the European Committee for Standardization (CEN) and the European Committee for Electrotechnical Standardization (CENELEC) — http://www.cencenelec.eu which develop and adopt European standards in a wide range of products, services and processes, as well as by the European Commission (www.ec.europa.eu) and the European Free Trade Association (http://www.efta.int/).

<u>SESEI Objectives</u>: The SESEI's mission is to enhance the visibility of European standardization, to increase the cooperation between Indian and European standardization bodies and support European companies facing standardization related issues hampering market access to India. The SESEI project has the ambition to facilitate EU-India cooperation in standardization matters, as well as to support Regulatory Dialogue, activities involving the European Commission (EC), EFTA, the European Standardization Organizations (ESOs - CEN, CENELEC & ETSI) and the Indian Government, TSDSI, BIS and other Indian stakeholders in support of an increase of trade flows.

The project also supports India in standardization related aspects of its integration in the WTO trading system, by identifying all potential opportunities for enhanced international cooperation and global harmonization of standards, namely with ISO and IEC. Ultimately, the SESEI project aims at contributing to the removal of Technical Barriers to Trade (TBT) both between EU and India and globally, thus supporting European and Indian industries by facilitating international trade.

- III. Latest Developments and current state of play covering Standards development & Policy Initiatives in India to support the sectorial growth;
- IV. Tentative projection on future developments and impact on market perspectives

Note: The content should be proficiently supported by data and all references should be properly marked.

Milestones: The proposed milestones for the delivery and completion of the study report are:

- End of Nov 2017: Selection of Company / consultant for preparation of Study Report
- Mid of Dec 2017: Contract finalization and agreement on Table of Contents
- Mid of Jan 2018: 1st draft report to be ready for submission to SESEI
- Beginning of Feb 2018: Revised 2nd draft to be submitted incorporating the changes / suggestions provided by SESEI and Stakeholders
- End of Feb 2018: Finalization of Report along with color scheme, presentation, cover page, etc.
- Mid of March 2018: Final Printable copy to be shared
- End of March 2018: Final Approval by SESEI and Stakeholders for its printing
- 9th April 2018: Receipt of Final Report in soft and hard copy
- Author/ Consultant to present the finding of the Study report during the proposed 3rd EU India Conference on Standards & Emerging Technologies scheduled to be held on 26th April 2018
